- Quizzify is an interactive quiz platform that can enhance your knowledge on various aspects of health, including mental, physical, and financial well-being. It's designed to make education fun and engaging.
- How can Quizzify help me save on my medical insurance premium?
- A By completing six quizzes **OR** three quizzes and a preventive exam by September 30, 2025, you'll qualify for a monthly premium discount on your 2026 medical plan premium. It's a simple and rewarding way to stay informed and save money!
- What topics do the quizzes cover?
- The quizzes cover a wide range of topics, including:
  - · Chronic disease prevention
  - · Nutrition and exercise
  - Sleep, stress, and anxiety management
  - Financial literacy
  - And much more!

- **Q** What is the deadline to complete the quizzes?
- A The deadline to complete three or six quizzes is September 30, 2025. Be sure to complete them by this date to qualify for the medical premium discount.

- A No, Quiffizy is only available to active full-time employees.
- Will completing more quizzes earn additional points for the Wellness Shop?
- A No, Quizzify is directly linked to the medical premium.

- Is there a minimum number of employees who need to participate to earn the discount?
- A No, there is not.
